

# Alzheimer's Research UK Grant Application System Terms of Service

## 1. Terms and conditions of use for the CC Grant Tracker Website ("the Website").

Subject to these terms and conditions, Alzheimer's Research UK grants you permission to access the Website, however, you may not (and not permit anyone else to) copy, modify, create a derivative work of, reverse engineer, decompile or otherwise attempt to extract the source code of the Software or any part thereof, unless this is expressly permitted or required by law, or unless you have been specifically told that you may do so by Alzheimer's Research UK, in writing. You may not use the Website for commercial use, collecting data or soliciting business.

## 2. Accepting the Terms

By using the Website you are agreeing and understand that Alzheimer's Research UK will treat your use of the Website as acceptance of the terms and conditions.

## 3. Provision and Termination of the Website by Alzheimer's Research UK

### 3.1

Alzheimer's Research UK may change these terms and conditions from time to time without prior notice to you. Alzheimer's Research UK will make a new copy of the terms and conditions available at [www.alzheimersresearchuk.org](http://www.alzheimersresearchuk.org) and will treat your continued use as acceptance of the updated terms and conditions.

### 3.2

Alzheimer's Research UK may suspend or terminate (permanently or temporarily) use of the Website (or any features within it) at any time at Alzheimer's Research UK's sole discretion and without notice. Alzheimer's Research UK may terminate your use of the Website with immediate effect if you breach any of these Terms.

### 3.3

You may stop using the Website at any time. You do not need to specifically inform Alzheimer's Research UK when you stop using the Website.

### 4.1

### 5.1

7.2

You acknowledge that your use of the Website does not grant you any right, title or interest to any content you access on or through the Website unless such right, title or interest has been expressly recorded in a separate written agreement with Alzheimer's Research UK,

## **10. General legal terms**

10.1

If any court of law, having the jurisdiction to decide on this matter, rules that any provision of these terms and conditions are invalid, then that provision will be removed from the terms and conditions without affecting the rest of them. The remaining provisions of the will continue to be valid and enforceable.

10.2

The terms and conditions, and your relationship with Alzheimer's Research UK under them, shall be governed by English law. You and Alzheimer's Research UK agree to submit to the exclusive jurisdiction of the courts of England to resolve any legal matter arising from the terms and conditions. Notwithstanding this, you agree that Alzheimer's Research UK shall still be allowed to apply for injunctive remedies (or an equivalent type of urgent legal relief) in any jurisdiction.
